

THE SOUTHEND BOROUGH COUNCIL (WAITING, LOADING AND STOPPING AND PARKING PLACES) (MAP BASED) (CONSOLIDATION) ORDER 2021

THE SOUTHEND-ON-SEA CITY COUNCIL (WAITING, LOADING, STOPPING AND PARKING PLACES) (MAP BASED) (INCREASED CHARGES) (VARIOUS AMENDMENTS) AMENDMENT NO. 2 ORDER 2024

Southend-on-Sea City Council in exercise of its powers under Sections 1, 2, 4, 45 and 46 under the Road Traffic Regulation Act 1984 (as amended) ("the 1984 Act") and the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the 1984 Act, hereby makes the following Order:

1. Without prejudice to the validity of anything done or to the liability incurred in respect of any act or omission before the coming into operation of this Order The SOUTHEND BOROUGH COUNCIL (WAITING, LOADING AND STOPPING AND PARKING PLACES) (MAP BASED) (CONSOLIDATION) ORDER 2021 No. 1 (To be known as 'The 2021 Order') and shall have effect;
 - (i) The items represented on the plans in Schedule 1 to this Order shall replace those plans as listed in the appropriate Schedule to The 2021 Order (as amended).
 - (ii) The removal of permits and charges described in Schedule 2 to this Order from Article 5 of The 2021 Order (as amended).
 - (iii) The insertion of new entries and new charges described in Schedule 3 to this Order into Article 5 of The 2021 Order (as amended).
 - (iv) Introduce the following definition into Article 2 (b) to the 2021 Order (as amended):

"Educational Permit" means a permit which can only be issued in accordance with the Council's terms and conditions to an eligible school included in the School Staff Permit scheme within a parking permit scheme area or specified car park.

2. The effect of this Order is to (this article is an explanatory note this is not part of the Order):
 - (i) Extend the operational and chargeable period for Zone 1A, to include Monday – Sunday 8am - 9pm affecting the following roads: Chalkwell Esplanade, Eastern Esplanade, Hartington Road (shared-use bays), Lucy Road (shared-use bays), The Leas, Thorpe Esplanade, Western Esplanade;
 - (ii) Introduce a Tradesperson Permit (On- and Off- street), and Educational Permit and a charge to Amend an existing Electric Vehicle (EV) Permit to be included in Article 5 of The 2021 Order; and
 - (iii) Remove the Seafront Permit , Voluntary Sector Permit, Tradesperson Permit (On-street only) and Tradesperson Permit (On- and Off-street) from Article 5 of the 2021 Order.

3. The remainder of THE SOUTHEND BOROUGH COUNCIL (WAITING, LOADING AND STOPPING AND PARKING PLACES) (MAP BASED) (CONSOLIDATION) ORDER 2021 (as amended) shall remain in full force and effect.
4. This Order shall come into effect on the 1st day of July 2024 and may be cited as "THE SOUTHEND BOROUGH COUNCIL (WAITING, LOADING AND STOPPING AND PARKING PLACES) (MAP BASED) (CONSOLIDATION) ORDER 2021. THE SOUTHEND-ON-SEA CITY COUNCIL (WAITING, LOADING, STOPPING AND PARKING PLACES) (MAP BASED) (INCREASED CHARGES) (VARIOUS AMENDMENTS) AMENDMENT NO. 2 ORDER 2024".
