Notice is hereby given that Southend-on-Sea City Council (hereinafter referred to as “the Council”) in exercise of its powers under Sections 1, 2, 4, and 122 of the Road Traffic Regulation Act 1984 , and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the 1984 Act has made the following Orders:

- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Wren Avenue, bend) Amendment No.7 Order 2024
- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Canewdon Road – Permit Parking Bays) Amendment No.8 Order 2024
- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Carlingford Drive - Outside No.215) Amendment No.9 Order 2024
- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Bournemouth Park Road – outside No.359) Amendment No.10 Order 2024

PTO1094 – Wren Avenue bend

To introduce No Waiting at Any Time (double yellow line) restrictions on the bend of Wren Avenue, on both sides of the road, from the existing restrictions at and opposite the junction of Anstey Close to the southern property boundary of No.54.

PTO1099 – Canewdon Road – Permit Parking Bays

To revoke two of the current Shared Use, Pay and Display and Business Permit Holders bays, on Canewdon Road, on the south side, to the right of the junction with Hadleigh Road and to replace these with two Permit Holders Only (Zone MW) 8am – 6pm parking bays.

PTO1070 – Carlingford Drive outside No.215

To revoke 2.4 metres of the Resident Permit Holders Only parking bay (Zone H) Mon-Fri 9.30am-4.30pm. The resident permit holder bay will then be 11.9 metres. To extend the existing No Waiting, Mon-Fri, 9.30am-4.30pm by 2.4 metres.

PTO1073 – Bournemouth Park Road outside No.359

To revoke the Two-wheeled Parking Bay and replace with No Waiting at Any time from the Bus Waiting bay southwards for 10 metres.

These changes will amend the following Order: The Southend Borough Council (Waiting, Loading and Stopping and Parking Places) (Map Based) (Consolidation) Order 2021 (as amended) (to be known as ‘The 2021 Order’). The remainder of ‘The 2021 Order’ will remain in full force and effect. Map-based Schedules to replace plans in the appropriate schedule of ‘The 2021 Order’ (as amended).

The amendments shall come into operation on 5th December 2024 and may be cited as:

- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Wren Avenue, bend) Amendment No.7 Order 2024
- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Canewdon Road – Permit Parking Bays) Amendment No.8 Order 2024

- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Carlingford Drive - Outside No.215) Amendment No.9 Order 2024
- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Bournemouth Park Road – outside No.359) Amendment No.10 Order 2024

Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the powers of the relevant section of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with may, within six weeks from the date on which the Orders were made, make an application for the purpose to the High Court.
