

THE SOUTHEND BOROUGH COUNCIL (WAITING, LOADING, STOPPING AND PARKING PLACES) (MAP BASED) (CONSOLIDATION) ORDER 2021

THE SOUTHEND-ON-SEA CITY COUNCIL (WAITING, LOADING, STOPPING AND PARKING PLACES) (MAP BASED) (BOURNEMOUTH PARK ROAD – OUTSIDE NO.359) AMENDMENT NO.10 ORDER 2024

Southend-on-Sea City Council in exercise of its powers under Sections 1, 2, 4, and 122 under the Road Traffic Regulation Act 1984 (as amended) (“the 1984 Act”) and the Traffic Management Act 2004 (“the 2004 Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the 1984 Act, hereby makes the following Order:

1. Without prejudice to the validity of anything done or to the liability incurred in respect of any act or omission before the coming into operation of this Order, The Southend Borough Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Consolidation) Order 2021 (as amended) (To be known as ‘The 2021 Order’) shall have effect as though;
 - (i) The items represented on the plans in Schedule 1 to this Order shall replace those corresponding plans as listed in the appropriate Schedule to The 2021 Order (as amended).

2. The effect of this Order is to (this article is an explanatory note this is not part of the Order):

To amend the 2 Wheel Parking in Bournemouth Park Road to facilitate the installation and usage of two vehicular crossovers. Further details and exact locations effected by the amended Traffic Regulation Order (TRO) are as follows:
Bournemouth Park Road (west side o/s No/359) -
To revoke the 2 Wheel Parking Bay and replace with No Waiting at Any time from the Bus Waiting bay southwards for 10m.

3. The remainder of The Southend Borough Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Consolidation) Order 2021 (as amended) shall remain in full force and effect.

4. This Order shall come into effect on the 5th day of December 2024 and may be cited as “The Southend Borough Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Consolidation) Order 2021. The Southend-on-Sea City Council (Waiting, Loading,

Stopping and Parking Places) (Map Based) (Bournemouth Park Road – Outside No.359)
Amendment No.10 Order 2024”.

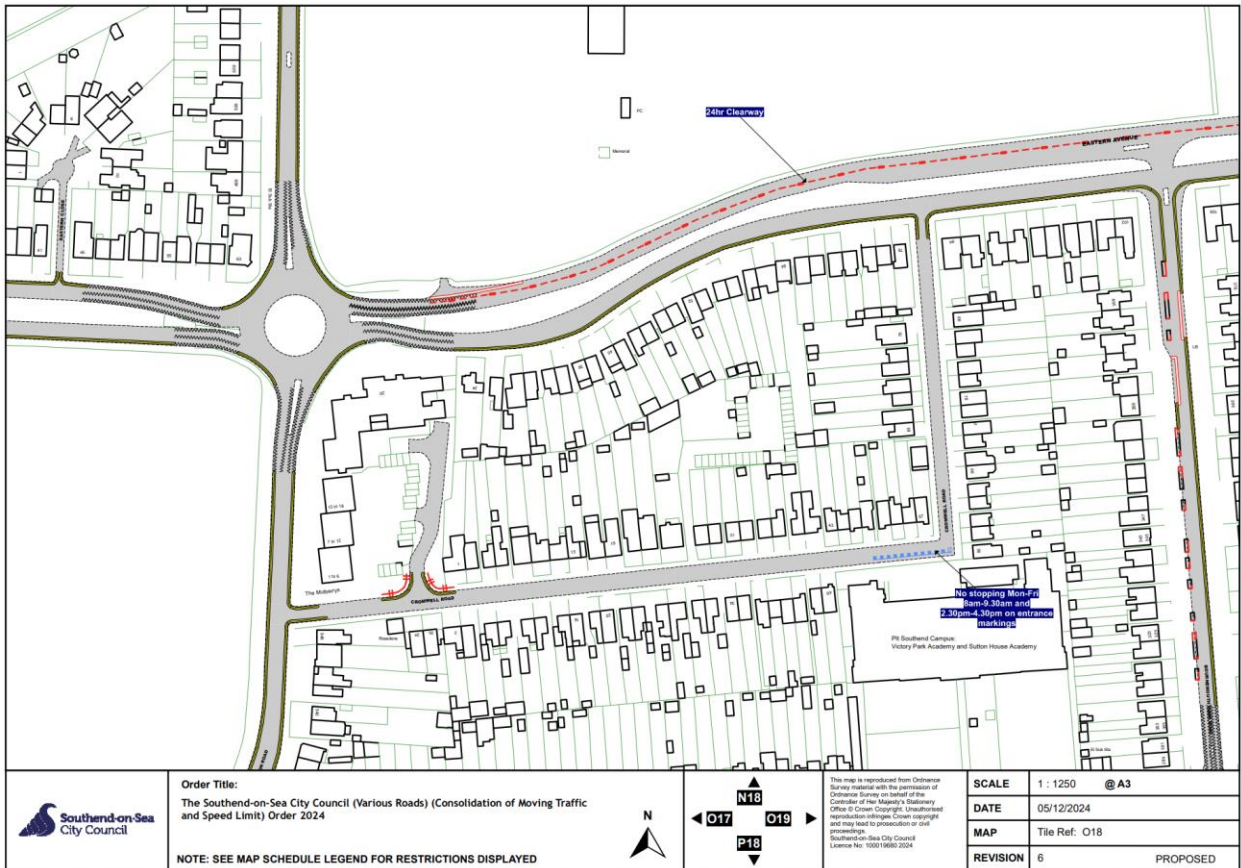

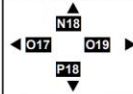
