

Statement of Reason

Proposal

The proposal is to:

- To extend the current No Waiting at Any Time (double yellow line) restrictions on York Road at the junction with Southchurch Avenue (north side), by 4.6 metres.
- To introduce No Waiting at Any Time (double yellow line) restrictions on York Road outside No.185 (north side), for 9.8 metres, eastwards towards Honiton Road.

Reasons

The proposals are designed to improve accessibility for refuse vehicles adjacent to No.181 York Road and also onto St Erkenwalds Court. This will allow refuse collections. The permanent amendment to the parking restrictions in this area will ensure parking and traffic is managed while maintaining adequate access for emergency vehicles and general traffic flow, continuously. This is consistent with the Council's Corporate Plan; a safe city with a good quality of life for all.

Road Traffic Regulation Act 1984

The sections which the City Council are using for the implementation of the proposed scheme as above are 1, 2, 4 and 122. The grounds that encompassed the reason for these proposals in Section 1 of the Road Traffic Regulation Act 1984 are:
