

THE SOUTHEND BOROUGH COUNCIL (WAITING, LOADING, STOPPING AND PARKING PLACES) (MAP BASED) (CONSOLIDATION) ORDER 2021

THE SOUTHEND-ON-SEA CITY COUNCIL (WAITING, LOADING, STOPPING AND PARKING PLACES) (MAP BASED) (WATSON CLOSE) AMENDMENT NO.\* ORDER 2025

Southend-on-Sea City Council (hereinafter referred to as “the Council”) in exercise of its powers under Sections 1, 2, 4 and 122 under the Road Traffic Regulation Act 1984 (as amended) (“the 1984 Act”) and the Traffic Management Act 2004 (“the 2004 Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the 1984 Act, hereby give notice that it intends to make the following Amendment Order:

- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Watson Close) Amendment No.\* Order 2025

The effect of the Traffic Regulation Orders (TRO) would be to extend the existing double yellow lines (No Waiting at Any Time) restrictions at the junction of Watson Close with Ness Road:

- on the west side of Watson Close to the property boundary of No.2 and No.3,
- on the east side of Watson Close to the property boundary of No.18 and No.19.
