 The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Bournes Green School – Parking Restrictions) Amendment No.4 Order 2025

The effect of the Traffic Regulation Order (TRO) would be to permanently amend the parking controls in multiple streets, around Bournes Green School within Southend-on-Sea City. All locations, extents and restrictions proposed are as stated in Schedule 1 to the Notice.

These changes will amend the following Order: The Southend Borough Council (Waiting, Loading and Stopping and Parking Places) (Map Based) (Consolidation) Order 2021 (as amended) (to be known as 'The 2021 Order'). The remainder of 'The 2021 Order' will remain in full force and effect. Map-based Schedules to replace plans in the appropriate schedule of 'The 2021 Order' (as amended).

The amendments shall come into operation on 6th March 2025 and may be cited as:

• The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Bournes Green School – Parking Restrictions) Amendment No.4 Order 2025

Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the powers of the relevant section of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with may, within six weeks from the date on which the Orders were made, make an application for the purpose to the High Court.
