The Southend-on-Sea City Council proposes to make the above named Order under Sections 1, 2, 3, 4 and 124 (and part IV of Schedule 9) of the Road Traffic Regulation Act 1984 ("the Act") as amended and the Traffic Management Act 2004 as amended and of all other enabling powers, and having regard to Section 122 of the Act after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act.

The effect of these Orders would be to amend the moving traffic and waiting restrictions on High Street and the surrounding roads in Southend-on-Sea as follows:

Introduce to The Southend Borough Council (Waiting, Loading and Stopping and Parking Places) (Map Based) (Consolidation) Order 2021 (as amended), a Restricted Parking Zone – No Waiting at Any Time at the following locations:

- (a) High Street, Southend-on-Sea
  - (i) Between Queensway and Weston Road,
  - (ii) Between Royal Terrace and Clarence Street,
  - (iii) At its junctions with London Road, Elmer Approach, Queens Road, Warrior Road, Whitegate Road and Southchurch Road.
- (b) Victoria Plaza, Southend-on-Sea, its entire extent.
- (c) Deeping, Southend-on-Sea, from its junction with Victoria Plaza eastwards for a distance of 45 metres.


Southend-on-Sea City Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 51 and 122 under the Road Traffic Regulation Act 1984 (as amended) ("the 1984 Act") and the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the 1984 Act, hereby makes the following Order:


- 1. Without prejudice to the validity of anything done or to the liability incurred in respect of any act or omission before the coming into operation of this Order The Southend Borough Council (Waiting, Loading and Stopping and Parking Places) (Map Based) (Consolidation) Order 2021 (To be known as 'The 2021 Order') and shall have effect;
  - (i) The items represented on the plans in Schedule 1 to this Order shall replace those plans as listed in Schedule 1 to The 2021 Order (as amended).
- 2. The effect of this Order is to (this article is an explanatory note this is not part of the Order):
  - a) Introduce a Restricted Parking Zone No Waiting at Any Time at the following locations:
    - i. High Street, Southend-on-Sea
    - ii. Between Queensway and Weston Road,
    - iii. Between Royal Terrace and Clarence Street,
    - iv. At its junctions with London Road, Elmer Approach, Queens Road, Warrior Road, Whitegate Road and Southchurch Road.
  - b) Victoria Plaza, Southend-on-Sea, its entire extent.
  - c) Deeping, Southend-on-Sea, from its junction with Victoria Plaza eastwards for a distance of 45 metres.
- 3. The remainder of THE SOUTHEND BOROUGH COUNCIL (WAITING, LOADING AND STOPPING AND PARKING PLACES) (MAP BASED) (CONSOLIDATION) ORDER 2021 (as amended) shall remain in full force and effect.
- 4. This Order shall come into effect on the XX day of XXXX 2025 and may be cited as: "The Southend Borough Council (Waiting, Loading and Stopping and Parking Places) (Map Based) (Consolidation) Order 2021. The Southend-On-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Various Amendments) Amendment No.X Order 2025".







#### **Statement of Reason**

#### **Proposal**

It is proposed to introduce a Restricted Parking Zone – No Waiting at Any Time on High Street, Southend-on-Sea between Queensway and Weston Road, between Royal Terrace and Clarence Street, and at its junctions with London Road, Elmer Approach, Queens Road, Warrior Road, Whitegate Road and Southchurch Road as a new permanent Traffic Regulation Order.

#### Reasons

Due to procedural impropriety relating to the waiting restrictions element of the scheme consultation and Traffic Regulation Order process, a decision has been made to abandon that order and to restart the advertisement and consultation for the waiting restrictions element only, ensuring a transparent and compliant process is completed. The scheme will not change in design or nature.

Any representations received in response to the waiting restriction element only of the original consultation remain valid and will be duly considered in line with relevant legislation and regulations. There will be no requirement for the public to re-submit comments. Any new representations will need to be submitted via the correct process, as set out on the Notice of Intent, within the dates specified.

#### **Scheme Reasons**

Following the making of a Pedestrian Zone and Pedestrian Cycle Zone on the High Street, it is proposed to introduce no waiting at any time restrictions which will strengthen and compliment the pedestrian scheme to ensure that vehicles are not parked on the pedestrianised area. The improvement to the High Street are following the Central Government's production of the National Security Policy Framework which means there is a need to protect public areas (where reasonably practical) where large numbers of people may congregate.

This scheme will aim to protect members of the public and manage the day to day operation of the city centre. A bollard system will be in place and operated in accordance with the provisions of the traffic regulation order which was made earlier this year to minimise access, to effectively maintain safety for all road users.

The scheme will further formalise the Pedestrian Zone in Southend-on-Sea High Street by preventing vehicles from waiting at any time.

The consultation process will include engagement with relevant stakeholders including the BID.

#### **Road Traffic Regulation Act 1984**

The sections which the City Council are using for the implementation of this order as above are 1, 2, 3, 4 and 124 (and parts III & IV of Schedule 9) of the RTRA 1984.

In addition, thorough consideration was given to the factors set out in Section 122 of the Road Traffic Regulation Act 1984 in proposing this scheme.

Traffic Signs Regulations and General Directions 2016

All of the associated signing and lining will be in accordance with Traffic Signs Regulations and General Directions (TSRGD) 2016.

Equality Act 2010

Thorough consideration was given to the equalities duty of Southend-on-Sea City Council under Section 149 of the Equality Act 2010.

#### **Due Regard for Traffic Orders and Notices**

The Southend-on-Sea City Council has a duty to give 'due regard to' the following three aims of the public sector equality duty (section 149 of the Equality Act 2010) during the development of the policy.

- Eliminate discrimination, harassment and victimisation and any other conduct prohibited by the ACT:
- Advance equality of opportunity between people who share a protected characteristic and people who do not share it; and
- Foster good relations between people who share a protected characteristic
